Defines health care provider as any licensed chiropractor, dentist, dental hygienist, acupuncture practitioner, massage therapist, nurse, occupational therapist, optometrist, pharmacist, physical therapist, psychologist, marriage and family therapist, dietitian, radiologic technologist, pathologist, audiologist, veterinarian, and their legal representatives. -- Redefines medical tort to mean a negligent act or omission to act by a healthcare provider in the rendering of professional services, or the rendering of professional service by a healthcare provider without informed consent provided that such services are within the scope of services for which the provider is licensed and which are not within any restriction imposed by the licensing agency or licensed hospital. -- SB2412

Establishes that psychologist may apply to the board of psychology for a conditional prescription certificate and the application shall be approved and be accompanied by evidence satisfactory to the board. Requires psychologist holding conditional prescription certificate continue to hold a current license to practice psychology in Hawaii, malpractice insurance, inform the board of the name of the prescribing mental health professional under whose supervision the psychologist will prescribe psychotropic medication, maintain an ongoing collaborative relationship with the doctor of medicine who oversees the patients general medical care. Prohibits psychologist holding a conditional prescription certificate delegate prescriptive authority to any person. Requires a psychologist holding a conditional prescription certificate authorized to prescribe controlled substances to file all individual federal Drug Enforcement Administration registration numbers with the board. Requires a psychologist may apply to the board for a prescription certificate and meets all requirements as determined by rule by the board for obtaining a prescription certificate. Requires the board to adopt rules and establish requirements and procedures for obtaining and renewing a conditional prescription certificates, a prescription certificate, and set a reasonable application and renewal fees. Prohibits psychologist holding a conditional prescription certificate or prescription certificate to administer or prescribe a narcotic and establishes an exclusionary formulary list. Authorizes the department of commerce and consumer affairs to establishes a joint formulary advisory committee to periodically review the exclusionary formulary list. Requires the formulary advisory committee to recommend amendments to the exclusionary formulary list and review the exclusionary formulary list no less than once per quarter. Allows a person to use the title of industrial / organizational psychologist; provided that the person registers with the board. Requires the state health planning and development agency report to the legislature, including any proposed legislation and assessing the viability of continuing prescriptive authority for psychologists. Act to be repealed on July 1, 2014 (sunset). -- SB2415
